

### Grade Stabilization for Sediment Reduction in the Thief River

• Submitted information for a BWSR Clean Water Story about the project.

- Submitted a short article about the project for the Marshall County newsletter.
- Started composing initiatives, funds, and a work plan within BWSR's eLINK4Web reporting system.



# **Thief River Watershed Assessment Project (Watershed-Based TMDL)**

- Revised the project's work plan so that it is now split into two phases.
  - O We will be approximately two years into the four-fiscal-year period over which the funding was allocated before a contract is signed. The funding was approved for the fiscal years of 2010 2013. The state's 2010 fiscal year actually started on July 1, 2009. So, by July 2011, there will only be two years left to complete a four-year project unless our expectations are revised.
  - o Phase I will take place in 2011-2013.

- o Phase II will take place in 2013 2015.
- o Phase I Budget: \$185,000
  - The MPCA recommended adding \$35,000 to the project as a whole to increase the budget for civic engagement.
- o Phase II Budget: \$100,000

# **Thief River Watershed Assessment Monitoring Surface Water Assessment Grant**

- The RLWD was awarded a Surface Water Assessment Grant by the Minnesota Pollution Control Agency for sampling in the Thief River watershed. The RLWD will administer the grant while the Pennington and Marshall County Water Planners collect the samples. Nine sites will be monitored in 2011 and 2012.
- Additional nutrient sampling (including chlorophyll-a and pheophytin) will be added to the sampling plan for one site (S002-079) on the Thief River.

  - There are a handful of unsewered communities in the county, including Gentilly, Gully, Beltrami, Trail, Euclid, and Mentor. Funding may be available to help pay for treatment facilities.
  - Eroding shoreline along Union Lake is a major problem.

  - o RLWD Manager Ose reported on the BWSR grants that were awarded to the RLWD, impoundment water levels, and a ring dike in East Valley Township.
  - The Lower Red River Basin (Tamarac River and Two Rivers) has been targeted for the development of a watershed-based TMDL. Dan Money will likely be the local project leader.
  - O Spill Prevention, Control, and Countermeasure (SPCC) plans and regulations were discussed. SPCC plans are required for farms that store more than 1,320 gallons of oil or oil products in above ground containers where a spill could reasonably be expected to discharge oil to protected waters.
  - o The Agassiz Pool radial gates will remain wide open this winter.
